#### **Division News**

1. 2014 Spring Meeting: The Steering Committee and Executive Committee minutes are attached from our recent spring meeting in Louisville. The spring meeting was very upbeat and successful. Overall attendance was 220, which included 125 registered for the Technical Session. This compares to the 2013 spring meeting in Akron with overall attendance at 250, which included 91 registered for the Technical Session. The difference in overall attendance is due to more Emeritus coming to the 25-Year Club Luncheon and Welcome Reception in the Akron area.

Overall revenues were much higher for the 2014 spring meeting with a total of \$59,019 revenue vs \$45,295 revenue in 2013. This was due to additional technical registrants plus holding two Education Courses, with 17 people registered for the "Intro to Compounding" course and 7 people registered for the "Intro to Dispersions" course, with a total revenue of \$10,409. No education courses were held at the 2013 spring meeting. Accounting Manager Lakisha Barclay will submit an "End of Meeting Report" once we receive all invoices from the hotel to account for expenses.

2. Education: Education & Pubs Manager Christie Robinson advised that the "Intermediate to Advanced Compounding and Testing of Rubber" Course will be held in Akron on April 8-9 at 8:30am-4:30pm and again on April 10 at 8:00am-Noon. We currently have 21 people registered and \$27,410 in revenue. Other Education Coursed planned for the remainder of 2014 are as follows:

- 3. Strategic Plan: As a reminder, we will be conducting a strategic planning process in 2015, which will be put in the 2015 proposed budget and include a facilitator. I will check with the American Chemical Society to see if they can provide a facilitator like they did in 2007. This process will involve the Executive Committee, committee chairs and staff, as well as input from other members. The final 2016-2020 Strategic Plan is expected to be finished for approval at the fall meeting in Cleveland.
- 4. S&T Awards Banquet: The Steering Committee is seeking input on a possible change to the Science & Technology Awards Banquet and would appreciate comments from the Executive Committee (please send to me for consolidation). Two questions: First, should we go back to the former venue of holding the banquet as a Dinner in lieu of a Lunch (details of when the Goodyear Medalist and other award winners speak would need to be worked out if a dinner)? Second, should we change to hold the banquet at the Fall meeting in lieu of the Spring meeting (again logistical details would need to be worked out)? Expo & Meetings Manager Beth Berkheimer is tasked to provide input on costs and logistics for these two changes. The Steering Committee will be discussing at their July Steering meeting in Akron.
- 5. 2014 Student Colloquium: To date, we have a total of \$2,000 donated from the Ohio, New England and Los Angeles Rubber Groups in support of the 2014 Student Colloquium in Nashville. If your Rubber Group would like to make a donation, please contact Marketing Manager Gretchen Spear or Technical & Student Program Manager Linda McClure. The Division appreciates any assistance provided during our "even year" fall meetings.
- 6. Membership: The Division currently has 1,945 members. As of March 23, we have 14 corporate members that consists of 172 individual members (81 are brand new members to the Division). Membership Manager Heather Maimone and Education & Pubs Manager Christie Robinson had a very successful visit to the Twin Cities Rubber Group meeting two weeks ago. Together, they visited three companies in the surrounding area to discuss corporate membership and corporate training. 
