# "JobsOhio Today and its 2012 Strategic Plan"

#### A status update on JobsOhio and developments that may impact the polymer and chemical industries in Ohio

Daryl Revoldt, JobsOhio, director of legislative and community outreach

Daryl Revoldt joined JobsOhio in February 2012 and serves as its. Previously, he served as director of government relations for the Ohio Department of Development. In a career spanning nearly 30 years, Revoldt has held elective office as a councilman and mayor, worked as district director for a member of congress, acted as a regional representative for Governor Bob Taft, and managed government relations for an Ohio defense contractor. He also was a member of the Wayne Economic Development Council, serving as its Vice Chair, and the Area 7 Workforce Investment Board. Revoldt holds degrees from Miami University and The University of Akron.

# "Synthesis of Oligo-Isobutylene-Based Dendrimers for Targeted Drug Delivery"

Marcela Castaño, ORG Scholarship Recipient, Ph.D. Student, Department of Polymer Science, University of Akron

Dendrimers are well-defined, highly branched, spherical macromolecules of nanometer dimensions. They possess unique properties including uniform size, precise architecture and multivalent surface which can be further functionalized and make them attractive for biological and drug delivery applications. Dendrimers are synthesized via a controllable stepwise manner. Two main synthetic strategies are widely used in order to get the complex dendritic structures: the divergent approach and convergent approach. However, the synthesis of dendrimers remains an expensive and difficult process with a complex mixture of products, resulting in batch to batch reproducibility problems.
